A. GT County Commission, Sonny Wheelock, Commissioner No report

B. Station 10 Fire Department

Chief Down indicated that there were 20 fire calls and 26 EMS calls for a total of 46 calls for service. New gear has been received pursuant to a grant from the G.T. Band and has been issued to fire and EMS personnel. A 50/50 grant was applied for to cover the cost of half of a Kubota package which will help fight brush fires. Down said he attended and spoke at the Long Lake Association meeting. Station 10 is still searching for a new firefighter. The department is also searching for a 100 horsepower outboard motor for the fire boat.

C. TCAPS Bond Proposal – August 7, 2018 Election

Christine Thomas Hill and Kate Burwinkle shared information regarding the upcoming bond proposal for TCAPS. Hill said that there is no increase to taxpayers, just a continuation of the same rate. The millage will allow TCAPS another 10 year capital improvement plan.

A. Approval – New Firefighter – Station 10 Fire Rescue (removed from agenda)

B. Fireworks Permit - Meemo's Entertainment/Ace Pyro

Rosa said that the application was complete and all licenses and insurances were in place for the event to be held on June 30th.

C. Resolution No. 06-17/18-11 Parks Volunteers

Rosa said that this resolution included a job description for Park Volunteers. The language is very clear as to what volunteers can and cannot do in the parks with/without approval. Attorney Todd Millar has recommended adoption..

Schaub moved and Lemcool seconded to adopt Resolution No. 06-17/18-11 Parks Volunteers. The motion carried by a roll call vote

D. Metro Act Right of Way Permit Extension

This five year extension grants permission for certain utilities to use the Township's rights of ways. The Township will be paid an estimated \$13,500 each year for the rights.

Garvin moved and Wheelock seconded to approve the Metro Act Right of Way Extension through December 31, 2023. The motion carried.

12. Public Hearing for the Proposed 7/1/18 – 6/30/19 Long Lake Township Budget

Rosa opened the Public Hearing for the proposed 7/1/2018 – 6/30/2019 Long Lake Township Budget at 6:30pm. Rosa reminded that the budget is still in draft form. Rosa highlighted budget areas. It is a balanced budget based on the expenditures of \$1,454,609 and revenues of \$1,454,609 which will include a 2.5 % wage increase for employees and elected officials. The Fire Department is in the process of hiring another full time person which is included in the budget. No Public Comment was received so Rosa closed the Public Hearing at 6:35pm. The Board will hold a Special Meeting on June 28th, 2018 at 7:30am to adopt this Budget.

13. Current Budget Status

Two budget amendments were presented and reviewed.

Schaub moved and Wheelock seconded to approve the two proposed budget amendments as presented dated June 12, 2018. The motion carried.
